The Miami-Dade County Canvassing Board, comprised of Judge Lawrence King, Jr., as Chair, Judge Myriam Lehr, and Supervisor of Elections David Leahy, advises the Court that on Friday evening, November 17, 2000, the Miami-Dade County Canvassing Board voted, by a 2 - 1 vote, to conduct a county-wide manual recount of all votes cast for President in the November 7, 2000 election.

The Canvassing Board convened at 9:00 a.m. on Saturday, November 18, 2000, to establish the procedures to be utilized for said manual recount and announced its intention to commence the process on Sunday, November 19, 2000.


