VERIFIED MOTION FOR ADMISSION PRO HAC VICE

4. Counsel has represented Plaintiffs/Appellees Ruth D. Holmes, et al. since the inception of this litigation in June, 1999.


5. Counsel has read all applicable provisions of the Florida Rules of Judicial Administration and the Rules Regulating The Florida Bar, and this motion complies with those rules.
