**PETITIONER'S RESPONSE IN OPPOSITION TO MOTION TO ALLOW
COUNSEL FOR *AMICUS CURIAE* TO PRESENT ORAL ARGUMENT**

Petitioner Jews for Jesus, Inc., by and through its counsel, files this response in opposition to the motion of counsel for *amicus curiae* Joe Anderson, Jr. to allow him to present oral argument here in the instant case in support of Respondent Edith Rapp, immediately after he presents argument in the companion case, *Anderson v. Gannett Co., Inc.*

In effect, movant seeks leave to present argument in both cases, thereby obtaining “two bites at the apple.” Because such an opportunity would unduly prejudice Petitioner and provide movant an unfair advantage to remedy any perceived defects in his first argument, as well as to unduly enlarge his opportunities to address
