**NOTICE OF INTENT TO SEEK LEAVE TO FILE
AN AMICUS BRIEF ON THE MERITS**

The Florida Association of Court Clerks, Inc. (“FACC”), pursuant to Rule 9.370(d), Florida Rules of Appellate Procedure, hereby files this notice of intent to seek leave to file an amicus brief on the merits in support of Respondent should the Court accept jurisdiction in this matter.

The FACC is a non-profit voluntary association, whose membership includes each of the 67 elected clerks of the circuit and county courts throughout Florida. If the Court accepts jurisdiction, the Court will be required to interpret the Florida Constitution and Florida Statutes regarding the financial role and duties of clerks of court in Florida. Such interpretation would have state-wide application, and a reversal of the decision below could have significant and harmful implications on the clerks’ independent authority, responsibility, and liability with regard to county finances.
