Dennis Hernandez shall pay restitution in the amount of \$5,000.00 to Willie Horton, in the amount of \$4,500.00 to Nancy Grundy, in the amount of \$5,588.50 to Michael Gartner, in the amount of \$3,228.75 to Gregory Stepsky, in the amount of \$717.50 to Elizabeth Whitlock, and in the amount of \$731.25 to Lynne Hajj, under the terms and conditions set forth in the report and the consent judgment.


Respondent is further directed to comply with all other terms and conditions of the report and the consent judgment.

Judgment is entered for The Florida Bar, 651 East Jefferson Street, Tallahassee, Florida 32399-2300, for recovery of costs from Dennis Hernandez in the amount of \$12,000.00, for which sum let execution issue.
