RESPONDENT'S UNOPPOSED REQUEST FOR EXPEDITED CONSIDERATION OF PETITION FOR APPROVAL OF CONDITIONAL GUILTY PLEA AND IMMEDIATE EFFECTIVE DATE OF SUSPENSION

The Respondent, N. James Turner, through his undersigned attorney, files this Unopposed Request for Expedited Consideration of The Florida Bar's Petition for Approval of Conditional Guilty Plea for Consent Judgment and Immediate Effective Date of Suspension and says:

- 1. On or about January 30, 2012, the Respondent entered into a Consent Judgment with The Florida Bar providing for a 90-day suspension. As this Court is well aware, the Respondent had been a judge, but was removed from office per the Court's ruling in Case Number SC09-1182.
- 2. The Florida Bar filed its Petition for Approval of Conditional Guilty
 Plea for Consent Judgment (hereinafter "Petition") on or about February 16, 2012.
 - 3. The Respondent agrees with the allegations of the Petition.

- 4. It is the regular practice of this Court to make a suspension effective in thirty days, in order to give attorneys the opportunity to shut down their practices in an orderly fashion and protect the interests of clients.
- 5. The Respondent, anticipating the suspension, has not commenced practicing law in the months since he was removed from his judicial office. An affidavit verifying this assertion is attached hereto as Exhibit "A."
- 6. The Respondent requests that the suspension be effective on the earliest possible date, and if this Court deems appropriate, on the date of this motion.
- 7. The undersigned attorney has consulted with Bar Counsel and Staff
 Counsel for The Florida Bar. The Florida Bar objects to a retroactive suspension
 date (a date earlier than the date upon which the Court enters an Order in the case).
 However, they do not oppose this Request for expedited review and immediate
 imposition of the suspension period.

WHEREFORE the Respondent, N. James Turner, requests that this Court conduct an expedited consideration of this matter and enter its order accepting the terms of the Consent Judgment, with the effective date of the suspension being the date of the filing of this motion, or in the alternative, immediately upon entry of the Order granting the Petition.
